## **REQUIREMENTS**

- An Indian Nationality for an Individual Bidder or A company or organization registered and incorporated in India or A non registered company based, headquartered or having operating base in India.
- The Individual Bidder or The Company/ Organization authorized representative acting as the Bidder on behalf of such Company / Organization must be minimum 18 years of age.
- The Bidder must have a Valid Indian mobile number (to be used as the Bidder ID) and a Valid Email ID.
- The Bidder must submit his KYC documents like PAN, ADHAR, GSTIN (if Registered).
- The Bidder must Agree to the Auctioneer Company's User Agreement, Privacy Policy and relevant Sale / Auction Terms & Conditions, prior partaking in any Auction/s or placing any Bid/s on any Asset/s listed in such Auction/s.

## **REGISTRATION**

You may not be required yourself to register in the main website of DealMatrix or to access the Auction Service Home page. But you need to register yourself as a User of DealMatrix Auctions web portal to view details of Scheduled auction events and partake in such online auction & sale events. It would be duty of the Users to provide correct, complete and accurate information or details pertaining to them or their personal profile or organization profile and to update them from time to time. In case the mobile number is disabled or user wishes to change his mobile number, the only option is to create a fresh registration/ user ID. Users can use Forgot Password option at any point of time, in case of forgetting the password.

## **EMD / SD DEPOSITION**

## **BIDDING TERMS & CONDITIONS**

## **POST APPROVAL AUCTION**

The Auction is of Post Approval basis Auction. This means, each asset listed in the auction starts with a basic start price (below which bidding not allowed) and each asset have a Seller expected price which is the primary price expectation of the Seller for further consideration for approval. Meeting or crossing expected price does not guarantee to be winner of that asset. But chances of approval consideration by the seller are higher if the highest bid for any lot meets or crosses its expected price. Bidder can not claim to be winner of any asset falling short or meeting or crossing expected price, unless it is duly approved by the concerned Seller. Seller have full rights in considering & declaring highest bid of any asset, irrespective that it falls short, meets equal value or surpasses the expected price.

## **BIDDING RESPONSIBILITIES**

Bid Now feature or button may be used ONLY after clear understanding of facts & figures relating to any lot or Asset ID and agreeing to the specific Auction Terms & Condition applicable. By pressing Bid Now, you authorize DealMatrix Auctions to register your bid and the input monetary value you wish to buy that product/ item/ lot/ Asset referring to the concerned Asset ID. If your input bid value meets the specific auction bid criteria & satisfies the time factor, the system will register your bid with the input bid value in system & you'll get notification on screen confirmation on successful bid placing. Unless the confirmation is received, please do not be sure of bid placing & you may check for any error or restriction that prevented you to register your bid successfully. Always refresh page manually to check if your bid has been placed successfully, provided you are not outbid by other bidder/s at that time. To help you in alerting regarding your mistakes or mis typing on "Next Ask/ Bid Price", system will ask for your confirmation on your willingness to bid and the specific amount you want to bid for. You may cancel the bid or go back & enter any new wish bid value. But once you confirm, bid will be placed in system, provided auction specific bid criteria are met. ## **BIDDING TIMERS**

- Auction Starts at the pre-set & pre-declared date & time, mentioned in summary page of catalog. On exceptional case & beyond control incidents, it may start at a later time.
- Auction Closing starts at the pre-set & pre-declared date & time, mentioned in summary page of catalog. This means at this time bidding for the 1st asset closes. On Bid Extension cases, exceptional cases & beyond control incidents, it may start at a later time.
- Bidding for any lot will close only if there are no bids received in the specified bid extension time before scheduled closing. For example, If any bid is recorded within the last 2 minutes of scheduled closing, bidding time increases for specified time limit mentioned as "Bid Extension" in summary page of catalog. This can happen any number of times until bid free 2 minutes is achieved for that asset, prior to bid closing.

## **BIDDING LIMITS**

- **Monetary Limit** : A bidder will be allowed to bid until he crosses his Bid Limit, mentioned in the Summary page of catalog. For easy reference, a bidder will be allowed to bid till his total H1 bid value is 20 times of his deposited EMD/ SD. The limit, if crossed, system will restrict his bidding temporarily until his total H1 bid value falls below the (EMD/SD x 20) value, when he will be again allowed to bid further.
- **Bid Number Limit for Each Asset** : A bidder will be allowed to bid only the specified times for a particular Asset. Number of Bid left for each lot will be displayed on portal for bidder's reference. This is noted as Bid Masking in the summary page of the auction catalog.
- **Bid Number Limit for Asset Count** : A bidder will not be allowed to bid over 3 number of Assets (if lower EMD/SD is opted) or over 50 number of Assets (if higher EMD/SD is opted) in an auction. Upon start of the auction, every registered & qualified Bidder will be prompted to select the Asset/s which they want to bid for based on their opted EMD/SD. If any bidder wishes to bid for more than 50 assets, they are advised to bid using separate registration having separate User ID & separate EMD/ SD deposits.

## **PAYMENT TIMELINE**

Winner Bidder (for 1 asset or multiple) is supposed to pay Full Sale Proceeds & Auctioneer's Charges including GST, TCS (if applic), Parking Charges (if applicable), Other prescribed charges (if applicable) strictly within the specified & advised time line, without any delay whatsoever. A bidder will be responsible for reason/s of partial or non payment solely & will be treated as defaulter or violator of the auction rules & regulations (terms & conditions). The deadline or timeline for making full payment/s is mentioned in the summary page under Event Timelines section. Upon such incident where bidder is unable to make full payments within the specified timeline, DealMatrix and/or Seller have the full rights to cancel the Sale of such won assets (by bidder) & award sale favoring any other bidder (if deemed suitable) & actual winner (who defaulted) cant held Auctioneer or Seller responsible or can claim anything related to that. DealMatrix and/ or Seller is liable to forfeit the deposited EMD/SD amount of such bidder in full or partial, as decided by them.

## **PAYMENT MODE**

Both EMD/SD, Sale Proceed, Auctioneer's Charges & Other applicable charges are to be paid by bidder using allowed instruments that are described/ advised in the summary page of auction catalog. Demand Drafts & Pay Orders are accepted only from Nationalized Banks or Banks having Pan India operations & mandatorily have Core Banking services. ## **REFUND**

- Unable to participate in auction due to non realization or late realization of EMD/SD instrument.

For qualifying of refund applicability, a Bidder may NOT be:

- A defaulter or violator of auction terms & conditions.
- Using third party payment instruments to deposit his EMD/SD or any other payments.

All qualifying amounts which are to be refunded to Bidder which couldn't be transferred or refunded due to error in Bidder Bank Account related problems or wrong details submission by bidder or any other reasons & Bidder does not claim such refund in person, then all such amounts lying with DealMatrix for more than 6 months will be forfeited without any further recourse.

## **ASSET DELIVERY**

Asset/s will be delivered to winner bidder/s upon valid Delivery Orders issued by Sellers, from the location it is parked or kept during the auction. Delivery Order/s will be issued after realizing full sale proceed payments including Sale Price, GST, Parking Charges, TCS, any other applic charges & Auctioneer's Charges (whichever are applicable). Winner Buyer/s are advised to visit Parking Yard with Delivery Order & KYC/ Authorization & lift/ take delivery of the won asset/s, within the



specified timeline mentioned in Summary page of Auction catalog.
